ANNOUNCEMENT

Regarding tuition and fees for articulation programs of the Master of Business Administration with Andrews University (AU) Cohort 14 and Earlier

The International University (IU) – National University Ho Chi Minh City would like to announce the tuition and fees for those students (Cohort 14 and earlier) within the articulation programs of the Master of Business Administration between Andrews University (AU), USA and IU with the following detailed information:

1. Tuition and fees

Tuition for the entire course is 10,800 USD (Ten thousand and eight hundred US Dollars), (equivalent to 264,384,000 VND, with the exchange rate at Semester 2 - Academic Year 2023-2024 is 24,480VND/USD) divided into three payments, specifically as follows:

- **First Payment:** 40% of the total tuition fee, equivalent to 4,320 USD (corresponding to 105,753,600 VND, with the exchange rate at Semester 2 - Academic Year 2023-2024 being 24,480 VND/USD). The first payment must be completed before starting the very beginning subject.

- **Second Payment:** 30% of the total tuition fee, equivalent to 3,240 USD (corresponding to 79,315,200 VND, with the exchange rate at Semester 2 - Academic Year 2023-2024 being 24,480 VND/USD). The second payment must be completed at least two weeks before the start of the third specialized subject.

- **Third Payment:** the remaining total tuition fee, equivalent to 3,240 USD (corresponding to 79,315,200 VND, with the exchange rate at Semester 2 - Academic Year 2023-2024 being 24,480 VND/USD) minus scholarship deductions or other fees as agreed between IU and AU. The third payment must be completed at least two weeks before the start of the eighth specialized subject.

2. Payment method:

The payment is only made in VND. The equivalent tuition fee in Vietnam Dong will be converted according to the exchange rate announcement of the IU at the time of tuition collection.
